**SBIR Compliance Statement  
 REACH, and CA Proposition 65**

Santa Barbara Infrared (SBIR), a HEICO company, designs and manufactures standard and custom equipment for electro-optical testing and measurement. As a California-based company, SBIR strives to minimize the impact of its operations and products on the environment, and to comply with regulatory and statutory requirements. To that end, the statements below are being made with respect to SBIR's compliance to various government directives pertaining to materials used in SBIR products:

EC 1907/2006, Registration, Evaluation, Authorization and Restriction of Chemicals (REACH)	<p>The responsibility for fulfilling the requirements of REACH, such as registration lies with the importers established in the European Union, or with the only representative of a non-EU manufacturer established in the European Union. This does not apply to SBIR. Furthermore, SBIR and its subcontractors are considered to be a "Downstream User" as defined.</p> <p>As of the date of this document, and based on information provided by third parties, the substances of very high concern (SVHCs) from the most recent candidate list are not intentionally or knowingly used in SBIR products at levels <math>\geq 0.1\%</math> by weight. Furthermore, as of this date the applicable restrictions on substances per Annex XVII of REACH are met by SBIR, according to the scope reflected in Annex XVII.</p> <p>For certain product accessories (e.g. cables, smaller electronics modules), high temperature solders including lead may still be used, and potentially there are some electronic components which may still include lead in trace amounts. In these accessories, it is also believed that there are no SVHCs in excess of <math>\geq 0.1\%</math> by weight, but this has not been validated.</p> <p>Be assured that as the SVHC list evolves, if any SVHC is identified in any of our products above the threshold of <math>0.1\%</math> by weight we will communicate the required information to our customers (in accordance with REACH Article 33).</p>
State of California Safe Drinking Water and Toxic Enforcement Act of 1986 ("CA Proposition 65")	Proposition 65 applies to the consumer's exposure risk to those chemicals listed in "Chemicals known to the State to Cause Cancer or Reproductive Toxicity". There are no known or expected exposure risks for the delivered product. <sup>1</sup>
Polycyclic aromatic hydrocarbons (PAH)	There are no known PAH chemicals in this product.

<sup>1</sup> During the manufacturing process, component materials within the product's materials may use chemicals known to the State of California to cause cancer and birth defects or other reproductive harm; these risks exist only when chemicals are airborne or exist as respiratory sized particulate, or are handled directly.
